ANNUAL REPORT, May 2013

The Walter Reed Society, a tax-exempt 501(c)(3) organization incorporated in the District of Columbia (EIN 52-1961196), was organized exclusively for charitable purposes in 1996 to benefit Walter Reed Army Medical Center (WRAMC) and its educational, patient, treatment, and research activities. In 2011, the Society transferred its activities to the Walter Reed National Military Medical Center (WRNMMC), Bethesda MD.

The Society aims to preserve the legacy and renowned international reputation of Walter Reed, the man, and the institution named in his honor. It sponsors activities and funds projects and goods that enhance patient care services and support the welfare and morale of service members and other staff at the Nation's premier military medical center. Through the generous support of corporate and private donors, the Society has assumed an additional mission of assisting service members being treated at Walter Reed due to service in Iraq, Afghanistan and surrounding areas by helping them and/or their families in response to unmet needs during their care at the medical center.

COMMITTEES AND ACTIVITIES

Finance, Investment and Audit

The independent financial audit and submission of the Form 990 were completed by Ribis, Jones & Maresca, P.A. The Society records were found in compliance with generally accepted standard accounting principles.

In 2012, donations income exceeded grant expenditures which was a welcome reversal from 2011. Combined Federal Campaign, corporate and individual contributions to the Society totaled \$331,204. An impressive \$233,511 was distributed to support of activities, services and Warrior patients/families during 2012. Donor generosity has enabled the Society to grant \$2.2 million in assistance since 2004. At year's end, the net assets were \$1.4 million. These are updated figures since publication of the April newsletter.

Also, reporting and licensing requirements for DC, Maryland and Virginia were met.

Membership and Programs

Membership is open to all friends of Walter Reed and numbers 683. Recent membership initiatives include providing refreshments and distributing Society materials to attendees at the April and May Leader Forums at WRNMMC.

The traditional December Membership Holiday Gathering and Annual Meeting Brunch have continued at the USU Dining Room. Trying a new venue in December is being discussed.

Communications

A newsletter was published twice this year and the website has been kept up to date.

The official document file is maintained by the Secretary.

The formation of a committee to track member “happenings” is in progress.

Grants and Development

The Warrior/Family Support Grant Committee and the Projects Grant Committee continued to be active with more than \$233,500 distributed in assistance grants during 2012. Some major efforts include sponsorship of the Arts, Military + Healing Collaborative Initiative, purchase of 60 iPads to serve as adjunctive devices for Warrior rehabilitation, and funding monthly dinners for Warriors and their families at the American Legion Post 41 in collaboration with Helping Hometown Heroes.

History and Current Events

Updates on the former Walter Reed property were included in the newsletters.

Last month, the Assistant Secretary of Defense for Health Affairs, Dr. Jonathan Woodson, assumed control and jurisdiction over the operation and management of JTF CapMed, WRNMMC and FBCH. By 1 Oct 2013, JTF CapMed will have disappeared completely, as will Tricare Management Activity.

Walter Reed Mementos

The 2012 holiday collectible sold very well. It is anticipated that another will be designed this year along with a WRNMMC afghan.

We will miss COL Juan d’Avis, MC, USA, Ret., an active member who served as First Vice President and as a member of the Finance Committee.

I extend all best wishes for continued success to the incoming officers and the Society into the future.

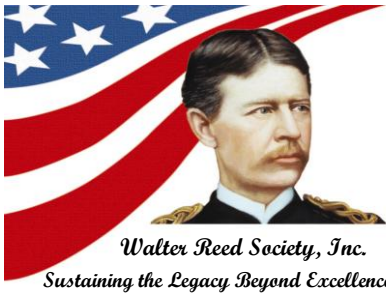

ASSISTING OUR WOUNDED WARRIORS AND FAMILY MEMBERS

The Walter Reed Society (WRS), a tax exempt 501(c) 3 charitable organization, was founded in 1996 (TIN 521961196). Organized for charitable and educational purposes, it benefits the Walter Reed National Military Medical Center (WRNMMC) and its educational, patient, treatment and research activities. Membership in the Society is open to all – officer, enlisted, active duty, Reserve, National Guard, retired, civilian, patient, family member, friends of WRNMMC. The WRS governing board is all volunteers and those involved in assisting our Wounded Warriors do so without remuneration.

Through the generous support of corporate and private donors, a fund was established in 2004 to assist servicemen and women being treated at WRNMMC due to service in Iraq, Afghanistan and surrounding areas with unexpected financial needs and provide specially identified equipment and services related to their care when other resources are not available. Grants are approved on a case by case review. Since its inception, hundreds of service members and/or their families have received assistance from the **WRS Warrior/Family Support Fund**. The total amount granted so far exceeds **\$2.2 million**.

Needs for assistance are forwarded through the Warrior Family Coordination Cell at the WRNMMC. A simple form is completed and the application is directed to a representative of the Society. Once received, requests are usually reviewed within 24-48 hours and, if approved, assistance is provided. Other opportunities to assist at the medical center may be presented to Society directors, all of whom volunteer their service, for consideration at regularly scheduled board meetings.
