No one knows more about sharing than the Walter Reed Society and the people who they assist could not be more thankful. Although all of them are grateful, several people expressed themselves with thank you letters and kind words, like those from Amber Colwell.

Mrs. Colwell, wife of SSG Sean Colwell and mother of three children diagnosed with Sensory Processing Disorder, wanted to thank the Society for assisting their family with paying the remaining \$6,175 for the use of a service therapy dog from 4 Paws for Ability. The organization strives to enrich the lives of people with disabilities through the training and placement of service dogs to provide individuals with compassion and promote independent living.


The three children, a 5-year old, and 21 month old twins, were diagnosed with the neurological disorder that causes them to be over stimulated very easily. The particular service dog provides a unique service for the children called behavior disruption.

"We believe this dog will significantly enrich their lives and our life as a family," said Mrs. Colwell. "We would otherwise not be able to afford this if it were not for the Walter Reed Society. Thank you. This means the world to us."

Another mother who was overwhelmed with the generosity of the WRS is Maria Free. Her son SPC Derrick Ford was injured in Afghanistan and while going through his treatment at Walter Reed Army Medical Center, his mother was by his side.

Being with her son and having other children back home in California created a financial strain on Ms. Free, but the WRS stepped in and paid \$4,048.

"I cannot express my gratitude in words and it is even more difficult to verbalize the feeling of relief you've given me," Ms. Free said. "I almost lost my breath at the approval of my request and I cried as I left the building to call my creditors to let them know payment was on the way. I love my son and I could not express any more pride for his commitment to this country and the sacrifice he made. Without your generosity I would have had to leave him in order to support my commitments back home. So thank you so very much."

A Spirit of Giving

Several organizations and individuals contribute to the Walter Reed Society being able to assist wounded warriors and their families in times of need. No donations are too small and it all goes toward an excellent purpose.

The Rock Bottom Foundation has been an avid supporter of the Society and this year they presented the WRS with a check for \$6,022. Eight wounded warriors were able to participate in the Brewmaster's Golf Tournament partnered by the Rock Bottom Foundation on Sept. 15, 2009.

Another strong supporter is the Spring Lake Fire Department, NJ, that donated \$3,500 to the Society along with more than 250 t-shirts from the five New York City Boro's Fire Departments that were distributed to wounded warriors throughout WRAMC.

Over the years, Exchange Monitor has held and dedicated their annual golf tournament to wounded warriors and promoted WRS as the charity to support. This year's tournament was held Oct. 14-16 in Amelia Island, Fla. Past donations have consisted of \$18,000 and \$16,000.

In Remembrance of MAJ Walter Reed

On Sept. 13, 1851, future Army physician Walter Reed was born in this small wooden house called "Belroi" in Tidewater, Va. The Reed family, Reverend Lemuel Sutton Reed, his wife Pharaba and their four children lived in the Belroi home for a year before relocating and settling in Farmville, Va. The Walter Reed birthplace has since been restored over the years to preserve its historical significance and is now maintained by the Joseph Bryan Branch of the Association for the Preservation Virginia Antiquities. The Joseph Bryan Branch is seeking to set up an endowment for the Walter Reed birthplace. This permanent endowment will ensure that Walter Reed's legacy will be remembered. All donations are tax deductible and all funds generated by the endowment will be used for the maintenance and operation of the Walter Reed birthplace. In addition, these funds will allow the branch to create education programs for visitors and for students. All donations are tax deductible and will be used for the preservation, maintenance and care of Walter Reed's birthplace.
