Walter Reed Society Moves from WRAMC to WRNMMC

Dear Members and Supporters,

The Society has moved into the newly renovated Building 17, Healthcare Operations Suite 2C, Cubicles 78 and 79, at Walter Reed National Military Medical Center. Although the office previously described was not approved, these cubicles have been provided for our use. We have settled into our new space, so stop by when you visit.

Our new address is: Walter Reed Society, 8901 Wisconsin Ave #303, Bethesda MD 20889-5600. To date, we do not have on-site internet access or a dedicated telephone number. We greatly appreciate the support of COL Chuck Callahan, Chief of Staff, WRNMMC, who recognized that preserving the legacy of Walter Reed, the man and the institution named in his honor, has been an integral part of the Society's mission since its founding in 1995. Integration of the Society within WRNMMC is appropriate to honor the history of both WRAMC and NNMC as the facilities merge to form a new internationally recognized identity. The Society's close association will insure its availability to assist with unmet needs associated with education, treatment, research, or specially identified equipment and

services related to patient care, in coordination with the Command or the Warrior Family Coordination Cell. Proximity to patients and caregivers will also facilitate another vital Society mission of financial assistance to wounded warriors and their families.

Loyal members of the Society packed our physical goods and files in the Pershing Suite on Sept. 30. As file space and storage space for mementoes at Bethesda is not yet available, these items have been moved to storage at the headquarters of the Association of Military Surgeons of the United States. We are most grateful to AMSUS for their support with this great need. We also heartily thank Joe Cevasco, Alberta Banen, and Bill Mason for their volunteer labor, equipment and transport to make the physical move a reality in short, efficient order.

Dear Walter Reed Society,

Our family would like to thank you for your financial gift to us. Earlier this year, we were in need of help with transportation. I needed to go home to Oregon and see my Dad. He has Alzheimer's and was put into a nursing home a couple months ago, and is not doing well.

In order for me to leave, my daughter needed to come out and stay with my son. He is 19 and was taken to Walter Reed on April 8. Matt was injured in Afghanistan. He was driving a vehicle that ran over an IED. His side took the brunt of the blast. His left leg was amputated about 3 weeks after he arrived at Walter Reed, The right leg is badly injured and the doctors continue to work on it.

Thank you to Mr. Bullis and Mr. Brand for their help. Walter Reed was our last option for help with airfare. It was such a blessing for our family. The stress of dealing with financial issues during this time is draining. We are thankful for the many different avenues that are available to help the families of Wounded Warriors.

Again, thank you very much for your generosity.

On December 9, 2010 my wife (1LT Lacey Hamilton) was ejected from a vehicle traveling in Afghanistan's Herat province. She suffered severe injuries to her neck, skull, face, collar bone and right hand. The news of her accident put a deep emotional strain on me and my family. Preparation for her return home brought on financial strains which we were not prepared to deal with alone.

Mr. Dan Bullis and the members of the Walter Reed Society were there to take on a huge part of the financial burden. In January 2011 the City of Wilmington, DE turned off the water to our house. Although we were not living in it we had planned to return when Lacey was released from the Warrior Transition Brigade. The Walter Reed Society provided a very generous gift which covered the entire past due balance.

I was traveling to Wilmington to plea a payment arrangement with the water company when Lacey called me with the news. I did not believe her! Thank you for helping us get our lives back. We have every intention of giving back at a future date.
